On 2/2/60, [WF 527-S\*] advised that HERMAN GREENSPUN,  
3842 Washington Boulevard, University Heights, Cleveland 18,  
Ohio, contacted the subject, [Commercial Counselor, Hungarian  
Legation,] and related that he is interested in buying  
antique jewelry from [Hungary,] would like to make a buying  
trip [to Hungary] in July or August, and requested a "business  
visa." (S) (JFK)

Source advised [LAKOS] assured GREENSPUN his full  
cooperation and suggested that he come to Washington, D. C.  
to talk matters over. GREENSPUN indicated he would (no  
date given). According to the source, GREENSPUN related  
he came to the United States in 1939. (S) (JFK)

WFO indices contain no information identifiable  
with the above GREENSPUN. u

Cleveland is requested to conduct sufficient  
investigation to further identify GREENSPUN and ascertain  
whether he possesses any potential for utilization under  
the DESECO program. (S) (JFK)

For the information of Cleveland Office, subject  
arrived in the United States on 1/30/60, and it appears  
he is going to be very active in promoting greater trade  
relations between the United States and [Hungary.] Subject  
was former [Director] of [Artex (Hungarian State Trading  
Firm for Arts and Crafts).] (S) (JFK)
