It would appear from the above that PIGNATELLO is undoubtedly a front for GIANCANA in Las Vegas and specifically at the Coach and Four Restaurant.

GERALD O'HARE

LV 10-C has previously reported that O'HARE in the past has handled the bets for employees and guests at the Desert Inn Hotel. In June, 1961, MORRIS B. DALITZ, principal owner of the hotel and a top hoodlum, national, issued instructions that O'HARE was not to be permitted to make any calls through the hotel switchboard to any race book in the City of Las Vegas.

O'HARE resides at 2401 Santa Clara Drive and is known to have at least two phones in his house. Hoodlums from other parts of the country have called these numbers during recent months.

As reported under the above heading, SAMUEL M. GIANCANA was in the Las Vegas area during July, 1961, at which time he made arrangements to purchase an interest in the Coach and Four Restaurant. He indicated he was going to set JOHN DREW, referred to hereafter, and others up as possible "dummy owners". Information appeared in a local Las Vegas newspaper in August, 1961, that JOHN DREW and JERRY O'HARE had purchased the Coach and Four Restaurant and had been approved for a liquor license to operate the restaurant.

It would appear from the above that in addition to handling bets on various sporting events, O'HARE is also possibly acquainted with GIANCANA and has been set up as a front by GIANCANA in the Coach and Four Restaurant.

LONNIE JOE CHADWICK

Las Vegas sources had advised that CHADWICK is a close personal associate of JOHN DREW. CHADWICK was employed until a few months ago as a pit boss at the Stardust Hotel, Las Vegas. He subsequently quit this job and has since been traveling to Los Angeles and other parts of the country with DREW. He was recently gambling in Reno when IRS Agents.
