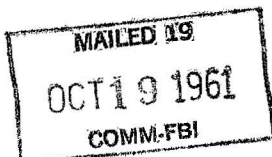

On 10/17/61, LA 4349-C advised as follows:

Informant was in Las Vegas, Nevada, on 10/16/61 at which time he met with MOE DALITZ at the Stardust Hotel. During meeting, DALITZ received telephone call. Informant does not know identity of caller. During conversation, DALITZ told caller, "JIMMY is in town. Why don't you go and see JIMMY and discuss it with him." Informant of opinion DALITZ was referring to HOFFA being in town.

Informant said while in Las Vegas, Nevada, he also met and talked with HANK GREENSPUN, publisher of the "Las Vegas Sun." Informant said that GREENSPUN has filed for an Application for Pardon with the AG and that they were discussing this fact. GREENSPUN was angry over the fact that he had not obtained his pardon from AG ROBERT KENNEDY. The fact that GREENSPUN obtained a Teamsters Pension Fund Loan for the "Las Vegas Sun" was discussed as a possible reason GREENSPUN has not received his pardon.
