MORRIS "SANDRA (LANSKY) knows you're here, but she doesn't know where."

MEYER discusses whether or not he should see her and all advise him not to see her, but to call her.

MORRIS "(FRANK) BREHENNEY called me this morning. He wanted to know how you were."

MEYER "The doctor must have told him.....unless BABE called him.

"Just shows you, you never know. Now there's FRANK. Look how he ended up."

MORRIS "Well I don't know. He's a very nervous fellow. He's got more money than God. He'll never spend the money."

MEYER "You're right."

MORRIS "You should see where he lives, a nine thousand dollar shack in the Bronx with his sister."

BOBBY "He's a very religious guy."

MEYER "Did SANDRA seem all mixed up."

BOBBY "Oh you know. She called me at the ticket office, of all places MEYER.

"I was talking to HARRY. He spent a few weeks in the (inaudible) Derby. He did very good there. (inaudible, Monterery mentioned) he gets very shakey when he's talking about money."

On 6/6/62, NY 3386-C-TE advised that BOBBY BLANCHE hangs out at the ticket agency at 53rd Street and Broadway. Informant stated that when SANDRA LANSKY was trying to contact BOBBY BLANCHE, she telephoned JACK SHERMAN of the Hollywood Ticket Agency, who, in turn, gave her the telephone number of the ticket agency at 53rd Street and Broadway. Informant stated that when SANDRA LANSKY contacted

BLANCHE at the latter agency, BLANCHE berated her for contacting him there and instructed her never to do that again. Informant added that BLANCHE has not been seen at the latter ticket agency since the above incident.

NY 3386-C-TE also advised that PAUL LANSKY, subject's son, was due in NYC on 6/76/62, to visit subject.

UNSUB II (apparently on crutches, remarks about falling out of a bus and mentions PETE SISKIND)

MEYER "He wound up with a heart attack."

UNSUB II "I owe him a couple of thousand."

The NYO will continue efforts to properly evaluate information being furnished by NY 3655-C\* and the Bureau will be immediately kept advised of all important activities concerning this informant.
