The following is a summary of the information furnished by NY 3845-C\* and NY 3851-C\* who were in a position to furnish information concerning MEYER LANSKY's activities in NYC during the periods 12/18-20/62 and 12/21-23/62 respectively:

## 12/18/62

Informant furnished information that subject and his wife, TEDDY LANSKY, attended a Broadway play on that date. At about 11:55 that evening, they returned to the Drake Hotel, NYC, where they were staying, accompanied by an unidentified couple who immediately departed.

## 12/19/62

Informant advised that subject went out of the Drake Hotel by himself early in the morning.

Subject's wife, TEDDY LANSKY, talked to a "Claire" (CLAIRE NOSSITER) and discussed being at the theater the previous evening. TEDDY indicated they were going to see the CAESAR show the following evening. She also remarked that on the previous evening, she and the subject went to the Stage Delicatessen.

Informant advised that TEDDY discussed her marriage with the subject and the following conversation took place:

TEDDY: "It has really dissolved a great deal, and all because of that little (obsceme) (SANDRY LANSKY). I can see the writing on the wall. She's definitely mental. She's incoherant. She makes no some at all. She siggles which is a sign of insenity. She's definitely gone and her child is gone. I've known she has been insane for a long time. A psychiatrict won't help her. She's a hopeless case. She should be put away. I keep telling Meyer this, but he won't listen to me".

TEDDY them requested CLAIRE to make reservations for four at Sardi's the following swiding.

TEDDY indicated that on Sunday (12/23/62) she was going out on the Island to stay with her grandchildren.

It should be noted that NY 3386-C-TE advised that on 12/24/62 MEYER LANSKY directed his daughter, SAMIRA LANSKY, to meet him at the office of the psychiatrist who treated LANSKY's first wife. Informant stated that when SANDRA LANSKY arrived at the psychiatrist's office, MEYER LANSKY was with the psychiatrist. According to the informant, the psychiatrist, without any examination, edvised SANDRA LANSKY that she was mentally disturbed and that if she did not do as he directed, he would have her confined to a mental institution. Informant stated that the psychiatrist directed SAMDRA LANSKY to report to him once a wack and that she was not to get married for the next two years. Informant stated that according to SANDRA LANSKY, her father "bought" the psychietrist in an attempt to control her octivities. Informant also advised that SAHMA LAWSKY has no intention of following her fether's request and that this has made her bate her father.

## 12/20/62

Informent adviced that TEDDY LANSKY received a telephone call from SANDRA LANSKY and the conversation was friendly and casual. TEDDY remerked that NETER was out with "Smiley". Informent also adviced that TEDDY invited SANDRA LANSKY to meet her for lunch and that SANDRA LANSKY did have lunch with TEDDY that date.

(NY 1386-C-TH has advised in the past that TEDDY LANSEY has referred to HYPLE SINGEL as "Smiley".) Informant (NY 2845-C\*) adviced that later in the afternoon, MAYER and TEDDY LANSKY returned to their room at the Drake Hotel and that TADDY received an incoming call from "Bo Bo". conversation was unintelligible. Immediately after TUDDY hung up, MEYER LANSKY apparently said smarking to TEDDY about her conversation over the phone, at which time TEDDY shouted in a hysterical voice "I'm not going to find out so forget about it, just forget about it. I'm not going to put mygelf in eny prison for you". HEYER's raply was unincelligible. TEDDY stated "it would be easier to go into that kind of a prison than to go into one mentally. A person is human schetimes". Again HETER's remark was unintelligible. TEDDY screamed at MITER, "you're driving me mute. Stop bothering me. You're getting old" and MEYER replied "you're some kind of a nut". TEDDY said "you're a biggor mut".
