11. Possibilities of obtaining desired information by other means (Explain in detail):

As pointed out in the case captioned ALBERT AGUECI, BOND DEFAULT, interviews were conducted of RANDACCIO and the MAGADDINO group without eliciting any information that they were acquainted with AGUECI. It was reported by BU 82-C\* that RANDACCIO and his associates, including MAGADDINO, were well aware of the fact that AGUECI was a Bureau fugitive, and that RANDACCIO was directly involved in AGUECI's murder shortly thereafter. This type of information could only be developed through a technical surveillance.

12. Risks of detection involved:

A 26 pair cable of the New York Telephone Company terminates in a basement two city blocks of this installation. The terminal is in a locked room and only accessible to New York Telephone Company employees. The telephone number TT 6-6034 is a private unlisted line used by DARLENE CRANN at 51 Essex Street. The equipment for this installation can be installed in the basement of 418-420 Richmond Avenue, in a locked room with access only by Bureau personnel.

13. Probable length of technical surveillance:

Two months, or until such time as RANDACCIO again opens up another business office in Buffalo or establish a regular enclosed meeting place with his associates.
