DE 919-C° advised on 1/29/63 that VITO GIACALONE had contacted DE 844-C, at which time a discussion was held concerning the fact that DE 844-C had recently been in a fight with FRANK FERLITO. According to the informant, VITO GIACALONE had indicated that he would talk with FERLITO so that this thing would not happen again.

The informant also advised that LOU (LNU) had visited with VITO GIACALONS on this date and that they had discussed LOU's recent trip to Hawaii. The informant stated that VITO GIACALONE had spent a considerable part of the day looking for and attempting to contact GEORGE GEORGE. an effort to locate GEORGE GEORGE, he had contacted Dr. H. A. Dr. PEYSER, had furnished GIACALONE with a telephone number which had been in the past an office utilized by GEORGE GEORGE in his handbook business. He also indicated that one JANICE (ANU) was employed in this office. According to the informant, GIACALONE attempted to locate GEORGE GEORGE at the number given him by Dr. PEYSER and had talked with JANICE. She had advised him that GEORGE GEORGE could possibly be located at the Michigan Metal Finishing Co. The informant stated that GIACALONE was able to reach GEORGE GEORGE at the Michigan Metal Finishing Co. and they had arranged to play hearts at GIACALONE's house on that evening. According to informant, VITO GIACALONE, Dr. PEYSER, GEORGE GEORGE, and MIKE POLIZZI did play hearts at GIACALONE'S.

The informant also advised that when VITO GIACALONE was in contact with DE 844-C, he had inquired as to the line on basketball games, and when this information was furnished GIACALONE had indicated that he did not want to bet at the odd which were given by DE 844-C but would possibly place a bet someplace else when he could get better odds.
