POLIZZI gets \$1000 or maybe \$1120 a week.

The informant stated that JOHN DUNN has invited VITO GIACALONE to visit with him at DUNN's home in Bloomfield Hills Michigan.

The informant stated that JOHN DUNN wants to buy half interest in the Living Room Lounge.
