On 3/30/64 and 4/3/64, informant advised that DOMINIC CORRADO and JOSEPH ZERILLI were still in Florida; however, they should be returning by the weekend of 4/5/64.

Informant related that PETE LICAVOLI is in the art business and has a location on Mack near Moross Road. He stated that LICAVOLI has apparently done very well with his art work and has made some lifelike paintings of some of the top hoodlums. He also stated that PETE LICAVOLI was in the spaghetti business and is operating the Five G's company in a building on John R. at Piquette Street.

Informant related that the mother of the payoff man for GUS CHIVAS lived near him and he will try to obtain further information regarding him.

According to the informant, TONY GIACALONE is supposed to have a hearing on 4/3/64, in court on his Motion to Dismiss but that he did not believe the actual decision regarding this case would take place on that date. He stated that BILLY GIACALONE is still in Detroit; however, it is believed that TONY GIACALONE is in Florida. Informant further related that "BIFFO" MACCAGNONE purchased a new Buick recently.

Informant advised that SAM GIORDANO is quite bitter about his conviction in the Palm furniture case since MIKE RUBINO got off and it looks like he will be taking the "rap" along with AYOTTE. He related that GIORDANO owes everyone money in town and it does not look like he will ever be able to pay them off.

According to the informant, "BARRELS" LOMBARDO is working the numbers business out of Pontiac for JOHN WHITE. He related that BENNY BOMMARITO, "BARRELS" father-in-law, has not worked for the syndicate during the past two years, yet he recently purchased a new 1964 Plymouth.

According to the informant, TONY MONASS (ph) is in trouble with VINCENT A. MELI since MELI is jumping MONASS' juke box stops. He is waiting to see DOMINIC CORRADO when he returns from Florida about this trouble.
