**CRIMINAL INTELLIGENCE PROGRAM**

On 1/29/62, KC 737-c\* advised that on same date at approximately 3:57 p.m., unknown individual, believed to be NICK CIVELLA, made call to CHARLIE (LNU) from the office of the Original Toy & Jobbing Mart, 303 W. 9th St., KCMO, as follows: "When you get it done, get in touch with OLLIE and leave word for me."

At 4:59 p.m., unknown individual and MORRIS KLEIN engaged in conversation as follows: MORRIS: "What time do we set this up here? This was 26 - 25 apiece. Highway, Louie, Nick, Tommy, Dude, Jay, me and Cork. So you have 26 - 25 and you have 10 .... Then we send five apiece over to me, Louie, Highway and Tommy. Nick didn't pay anything and Jay didn't. So you've got five up there. Then the last time you gave 2500, you remember. The six of us. That 2500 up there. Then there was 18, 22, 2520 dollars." Unknown individual: "Sure, I know darn good and well I had more than 18. This is more like it."

At 5:12 p.m. NICK CIVELLA called WALLY NASH at the Kansas Citian Hotel and asked what happened yesterday and how much he won. Asked whether there was any mail over there. Then stated: "Is it an envelope? Maybe it is for you. You been opening all this stuff? There's supposed to be. There's one over there now? An open card?" They then talked briefly concerning a female entertainer.

At 5:54 NICK CIVELLA called unknown female, probably LOLA (LNU), stating he would come by her house at approximately 6:45 p.m.
