WEEKLY SUMMARY

ReBulet to KC 3-7-62.

ReBulet requested that weekly summaries be submitted by this office and were to include information received from highly confidential sources.

In relation to NICHOLAS CIVELLA, Bufile 92-2761, KC 92-116, all pertinent information has been furnished to the Bureau in tri-weekly Airtels; however, it is to be noted that local gambling and income tax charges previously dismissed against CIVELLA have been reinstituted by the Jackson County Prosecutor's office. These reinstituted charges are being attacked by motions filed by CIVELLA'S attorney.

PCI [redacted] advises that ANTHONY THOMAS CIVELLA was in Las Vegas, Nevada, from 2-23-62 to 2-26-62. PCI stated further that members of the "Clique" are gambling on Wednesday nights in a room at the Park East Hotel. Further, she said the "Clique" is aware that the FBI will often surveil them when they go on trips by air transportation and, for that reason, they often travel by car and pick up a flight in another town in an attempt to prevent a surveillance.
