The Bureau is being kept advised of pertinent information developed by NC 737-C* through tri-weekly Airtels as well as weakly summarice submitted under the Criminal Intelligence Program. All information furnished by this source is being incorporated into the substantive case file in this division.

All offices which might utilize information reflected in this report should use extreme care and discretion in order to conceal the source so that its value will not be compromised.

In addition, certain information has been developed through CG 6486-C+ and EC 737-C+ concerning possible ownership of the Monte Carlo Club and a race track at Les Vegas, Movada. In both instances, a Mrs. JOSEPH BEOWN has a financial association with the locations and a separate lead has been set forth under the title "CRIMINAL INTELLIGENCE PROGRAM - KANSAS CITY DIVISION" for the Las Vegas Division, as well as the St. Louis, New Orleans and Cleveland offices, to conduct certain investigation in relation to the ownership of these locations.
