In relation to authorized mail cover placed on MORRIS SCHWARTZ, results of this mail cover have not been obtained from the U. S. Post Office Inspectors Office to date, thus it is not known whether subject is receiving mail through SCHWARTZ.

Mr. JAMES J. FEATHERSTONE, Department Attorney, has been contacted on a continuous basis by SA GEORGE F. LUECKENHOFF and has furnished no pertinent information concerning results of investigations by other governmental agencies.
