THOMAS CACIOPPO, aka AR (OO Kansas City)

Re Las Vegas letter to Kansas City dated 7/2/62.

Logical investigation in Kansas City, Missouri, fails to develop information indicating THOMAS CACIOPPO has returned to the Kansas City area since the middle of June 1962.

In early June 1962, KC 737-C* furnished information reflecting that THOMAS CACIOPPO and his brother, CHARLES CACIOPPO, also known as CHUCKIE MORGAN, had a long and serious discussion with NICHOLAS CIVELLA. The CACIOPPOS were complaining that they had recently been in Chicago, Illinois, and attempted to visit an individual named "HUMP" (phonetic). "HUMP" failed to recognize them or give them the usual courtesies. NICK CIVELLA explained to them that the reason for this lack of recognition was because they had not indicated to NICK CIVELLA they were going to Chicago prior to the trip, so that NICK was unable to telephonically contact "HUMP" requesting him to give the usual courtesies to the CACIOPPOS. Without this previous word, no courtesies are offered.

THOMAS CACIOPPO also complained extensively to the effect that he did not feel he was getting his fair share of money from NICK CIVELLA out of the profits of the organized criminal element in Kansas City, Missouri. NICK CIVELLA advised CACIOPPO he was getting his fair share, but the reason he has no money is because of his gambling losses, not because of curtailed income as his share of the profits.

On July 3, 1962, KC 315-C advised he had recently learned that THOMAS CACIOPPO had been in Las Vegas for the last several days prior to that date. He was unable to secure any information as to where CACIOPPO was staying or what the purpose was of his being in Las Vegas.
