Kansas City Div. was advised that the company leasing the premises at 305 West 9th St., had received notification that they would have to vacate the space at 305 West 9th St., as of September 1, 1962.

KC 737-C* developed information that the space was being taken over by the Original Toy and Jobbing Co., owned by MORRIS "SNAG" KKEIN, which is also the location where NICHOLAS CIVELLA has an office. The source also determined that the Original Toy and Jobbing Co. plans to cut a doorway between the space at 305 West 9th, and 303 West 9th.

In order to protect the source which is implanted in the wall between these two locations, the source was removed this date and the wall restored to its original condition. Kansas City Div. has installed a mate, in conjunction with the current telephone facilities at the location, 305 West 9th, and also installed a 23-A protector block in the rear portion of 305 West 9th, this protector block having been especially prepared by the FBI Laboratory and encompasses the equivalent of a mate. The above equipment was installed in the premises at 305 W. 9th, which is under the exclusive control of the Kansas City Div., and this installation was completed without trespass.

UACB, this equipment will be left in the premises when control of this area is relinquished on 9/1/62.

Inasmuch as the source will continue as a binaural source at the same location, Kansas City Div. is continuing this source under symbol number KC 737-C*.
