DR. [MEREWORKE] (PH) TO [SHAUL BAR HAIM] (S)

Caller, who indicated he was in some way associated with the [Embassy of Ceylon], questioned [B.H.] regarding [S] any developments concerning a technical assistance program, called [Technico] (ph), which caller and [B.H.] [S] have previously discussed. Caller pointed out the necessity of having this program "pushed" from outside [Ceylon]. Caller, whose father-in-law apparently has [S] just received an appointment to a high government position, indicated he would be leaving the U.S. shortly and that Mr. [PAULUSZ, Counselor] at the [Ceylon Embassy] [S] will be handling this program in the future. He stated that [the Embassy] is taking this program up with the [S] Dept. of State and that "we are thinking of an interview with ROBERT KENNEDY and telling him directly because of his current enthusiasm for Asian youth". He added that they are awaiting reaction and reply from the State Department. In outlining this program, caller remarked that 99.9% of business and industry in [Ceylon] [S] is directly related to agriculture. At the present time the value of land is dropping because of the nationalization of property. People no longer want to invest in land. The people of central [Ceylon] a rural area, are beginning [S] to enter into manufacturing and engineering. People, who are no longer interested in purchase of land, are now anxious to invest in manufacturing and engineering. According [S] to the caller, the [Government of Ceylon] is not interested in private industry. Because of the number of Marxists in the Government, the latter feel that the more private industry, the more the position of these Marxists will suffer. Therefore, private industry needs assistance from outside. [Technico] is a non-profit, independent [S] group designed to offer technical assistance and help not only to [Ceylon], but to other countries in the area [S] of the [Bay of Bengal]. Caller stated that the idea for [S] this program initiated with Representative [JOHN LESINSKI] of Michigan. [Sweden] is now interested in the program. [S] Caller said the support and participation of [Israel] in [S] this program is desired, noting that if the U.S. knows that [Sweden and Israel] are interested in it, the U.S. [S] will become more interested and consequently give the program the needed impetus.
