On 7/23/64, JAMES V. LA DUCA complained to SCRO regarding his daughter's association with the sons of SAM RANGATORE and (JOSEPH) TODARO.

On 7/29/64, CI reported that SCRO was apparently researching tax receipt records, possibly in connection with the IRS case.

On 8/7/64, CI furnished information relating to business activities of the Camellia Linen Supply Company.

On 8/11/64, CI learned that SCRO would be out of town for a few days.

On 8/13/64, CHARLES A. MONTANA advised the informant that his partner is out of town. Subsequently on 8/13/64 MONTANA and LA DUCA had a discussion which indicated LA DUCA's dissatisfaction with the manner in which SCRO is managing the Camellia Linen Supply Company and the inferior position forced upon LA DUCA by SCRO.

The information regarding the travel of SCRO supplemented and amplified information received from BU 280-C* on 8/13/64 and BU 297-C-TE on 8/18/64, which indicated that STEVE MAGADDINO and SCRO were in Atlantic City, New Jersey.

On 8/17/64, CI again furnished information regarding LA DUCA's dissatisfaction in his relationship with SCRO and information regarding financial aspects of the company's operation.

On 8/18/64, CI learned from LA DUCA that LA DUCA would be going away and that STEVE MAGADDINO was allegedly bedridden.

On 8/19/64, LA DUCA advised the informant that he would be leaving that afternoon or on the following morning. LA DUCA furnished details of his expected date of return.

On 8/20/64, MONTANA advised the informant that all of his partners were away.
