On 3/2/64, BU 280-C* advised that the subject and PETER (MACK) had a brief conversation during which MACK indicated that his sales of beer at the Pine Bowl Inn ran about 185 cases. He indicated that he had an appointment with distributors of five breweries on 3/2/64.

Subsequently the informant observed the subject, FRED RANDACCIO, JOHN (CAMMILLERI), SAM RANGATORE, PETER A. MAGADDINO, and one or two other unidentified men having a conversation. Several of the more pertinent topics discussed were inter-related and covered such topics as:

2. Corrupt Police Officers who have taken graft from MAGADDINO in connection with his numbers bank.
3. The advisability of picking a Jewish person to front for the organized Italian criminal element in the Buffalo area.
4. Potential locations where the organized criminal element could meet to discuss their business affairs with immunity from the authorities.

The conversation began with a criticism of some unidentified person who may be New York State Assemblyman STEVE GRECO. GRECO was criticized for attempting to avoid being seen with the subject and/or his associates. MAGADDINO remarked that this person found himself under certain conditions because of him. These conditions were not described as good or bad, but the impression was that they were good. An allegation was made that ROCKEFELLER (New York State Governor NELSON A. ROCKEFELLER) contributed \$50,000.00 to this individual, probably for a political campaign. The names mentioned in this portion of the conversation were:

12. (FNU) DE SAPIO (probably CARMINE DE SAPIO, former New York State Democratic Chairman)

On 2/20/64, BU 280-C* advised that the subject, JOHN CAMMILLERI, ROY (LNU) and two or three unidentified males, had a conversation which in substance indicated that some "girl" is going to be "hit" in all probability in Canada. The person making the "hit" may stay as a guest at the home of "SPERANZA's children" so that if questioned he can explain his presence in the area as being on vacation. In conjunction with this comment about "hit" one of the speakers (possibly ROY (LNU) or JOHN CAMMILLERI), tells another that he can "come back through Toronto. Come back from Canada." And then someone will let him know "It's been done."

The conversation further reflected that the speakers are concerned about some unidentified male person who may do something wrong. It is repeated several times throughout the conversation that if this person does anything wrong, he would be hurting himself. At the beginning of the conversation one of the speakers remarks to the other that he should be careful of cousin "LOUIE" (PH) because he either knows or will know something. It could not be determined if cousin "LOUIE" might be the person subsequently discussed as hurting himself if he does something wrong.

JOHN Yeah. I got to go home.

The information set forth above was furnished
in suitably paraphrased form to RCMP by SA JAMES P. MC MAHON
immediately upon receipt of the details of the information
from Kansas City. It appeared that the information contained
therein may possibly relate to Mrs. ALBERT AGUECI, and was
therefore furnished to RCMP, who in turn furnished it to
the Metropolitan Toronto Police Department since it related
to a possibly homicide.
