Set forth below is information furnished by BU 280-C* on the dates indicated:

December 11, 1963

CI advised that PETER A. MAGADDINO had a conversation with two individuals who were identified to the informant as NICK GABRIELE and JOE GUERRA (Ph) of Niagara Falls. After a general discussion concerning business activities, the group was joined by STEVE MAGADDINO. STEVE MAGADDINO began to enjoin against the administration in Niagara Falls and GUERRA mentioned the name of CHET ENDS (Ph). It appeared that ENDS told GUERRA that he was being transferred back to the city market. MAGADDINO then mentioned the name of TONY BAGS, who was identified as a former policeman and is now an Assistant City Treasurer in Niagara Falls. GUERRA commented about a newspaper article appearing on the preceding Sunday in which (Mayor DENT) LACKEY made reference to a Mr. X. GUERRA commented that LACKEY did not mention TONY BAGS but that is who Mr. X is.

The conversation continued in a general vein concerning the political situation in Niagara Falls, New York, and the recent testimony before the Senate Racket Committee. STEVE MAGADDINO stated that his own family and the name of MAGADDINO have been disparaged. In connection with the general political situation, MAGADDINO recounted a conversation he had with some unidentified man who is apparently a politician. MAGADDINO apparently told this individual, who was swearing and crying during the conversation, that he does not want to see this individual, does not have to beg from anybody, and does not need this individual. It appeared that this individual had turned down some request of MAGADDINO at a previous time.

A general discussion concerning Senate hearings involved (Assistant Chief of Detectives MICHAEL) AMICO. It was pointed out by the speakers that testimony before the Committee granted immunity from slander suits, but that AMICO would find himself in court if he said the same things in Buffalo. All of the participants in conversation engaged in praising the subject, who pointed out what a law abiding, respectful individual he is and the fact that he has assisted so many people. MAGADDINO commented that he had no police record, has never been a gambler in his life, and his only income is from legitimate business. At one point in the conversation, GABRIELE commented what a good time had been had by the subject, his wife and a doctor from Youngstown (Dr. GERARD CASCIO?) at a wedding anniversary for NICK PRICONATTI or TRICONATTI (Ph). PETER A. MAGADDINO then pointed out that these allegations have ruined their family's lives and that these people can make accusations without proving

Subsequently, JOHN CAMMILLERI joined the group and the conversation turned to the amorous exploits of the subject. In describing his amorous adventures as a young man with several prostitutes and nonprostitutes, the subject related that one prostitute wanted him to be her pimp, but he emphatically refused. He allegedly advised this woman that he would do many things to earn a dollar but would not condescend to earn one million dollars as a pimp. Thereafter the subject and the others present mentioned some of the better known pimps of by-gone days, namely, ENRICO GONDOLFO (Ph) and two brothers, ANDY and MIKE LA MACHIA.
