On 7-26-63, MM 851-C advised he had been in Kurby's Par on at least ten occasions during the past three months. Informant stated there has been evidence of gambling between the patrons but no indication that the sports ticker had been used to facilitate this gambling.

Records of the Southern Bell Telephone and Telegraph Company were reviewed by Mrs. IORRAINE EITER on 6-3-63, and she furnished information to IC ROSERT JOHN SCHAMAY to the effect that telephone number Union 5-9216 is in Kurby's Bar and is listed to JULIUS ZIMAND and NATHAN CLARK.
