Informant stated that he would be well pleased if the police department was able to convict and send TONY GIACALONE to prison but he says he will wait and see what happens. He said GIACALONE had become very big in Sicilian gambling circles since 12 or 14 years ago he was peddling the daily racing forms in prison to various bookmakers including himself. He further stated he wondered if the case would hold up in court for conviction since he read the newspaper he did not observe any information that Detroit Police Officer THOMAS had ever met GIACALONE in person.
