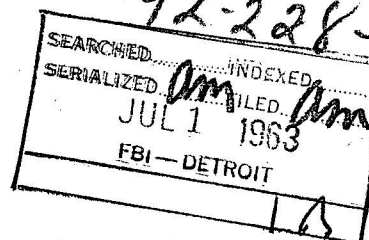

Informant stated that on about 5/24/63, RONALD KRAMER, the professional football player with the Green Bay Packers, came out to the Hillcrest Golf and Country Club with TONY TOCCO and TONY GIACALONE. He was later eating with these two plus BILLY GIACALONE. Informant stated that KRAMER spent the entire day with TONY TOCCO and later took TONY TOCCO's phone number and mentioned he would have to put this in code as he didn't want to get in any trouble over this. Informant stated that TONY TOCCO and RONALD KRAMER made an appointment to go to the Rooster Tail, a well known night club, at a later date.
