On March 22, 1963, Source furnished the following information:

Source advised that he observed activities at Melrose Linen Service, Inc. (MLS) Office and Plant during the Saturday morning of March 9, 1963. He stated that the only person who appeared to be at the plant was one of the woman employees, who drives a Pontiac with license AP 4767. This car is registered to F. PAUL TOCCO of 18020 Lister, East Detroit.

On March 14, 1963, at 1:40 p.m., there was parked in the garage of MLS a marcon Continental, AJ 4599. It is to be noted this car is usually driven by ANTHONY TOCCO. It is registered to WILLIAM TOCCO, father of ANTHONY TOCCO.

On April 4, 1963, source furnished the following information:

On Friday, March 29, 1963, at 11:50 a.m., there was parked in the garage of MLS the black 1963 Pontiac, ED 6977, usually driven by ANTHONY TOCCO. On the parking space of MLS at 1:50 p.m. there was a white DeSoto, MV 8326. This car is registered to MARY LEONE, 19465 Melvin, Roseville, for a 1956 Buick two-door.

On April 1, 1963, at 1:25 p.m. the pink Mercury, EJ 7283, driven by EDWARD KOERNER was on the MLS parking space.

On April 3, 1963, at 11:15 a.m., a 1963 Chevrolet, AD 9021 appeared. A white male, age 35, 5'10", slender, left this car carrying a brief case and entered the MLS Office. This car is registered to ERNEST I. PIZZIMENTI, 11168 Corbett, Detroit, for a 1963 Chrysler.

On April 4, 1963, at 1:30 p.m. on the street was the white over gray Continental, AM 4533, which is usually driven by TONY CIMINI.

At the same time there was driven into the garage a 1963 Chevrolet, AF 4759. The driver was an elderly white man. This license is registered to JOHN H. and EVELYN GAMBLE, 19732 Mansfield Avenue, Detroit, for a 1958 Ford two-door.

There was parked in the alley at the rear of MLS plant a brown Cadillac, CN 1460. It was occupied by two men, one a white male, 30, short, and the other a white male, 35 and short. Both went into the office of MLS. This car is registered to the Hughes Laundry Machine Company, 14401 Ford Road, Dearborn, for a 1961 Cadillac.

On April 8, 1963, source furnished the following information:

At 7:45 p.m. on April 7, 1963, there was parked in front of the MLS a late model blue 1962 Thunderbird, EM 8441. It is to be noted this car is registered to CALO LICATA, the person who actually operates MLS. On the parking

On April 15, 1963, source furnished the following information:

At 2:00 p.m. on April 9, 1963, source observed a maroon Cadillac, FE 1896, parked on the street directly in front of the MLS Office. This car is registered to ANTHONY GIACALONE, 701 Balfour, Grosse Pointe Park, Michigan. On the street beside this car was a late model brown Cadillac, FG 8933. There is no listing for this license.

On the curb parking space of MLS was the red Valiant, AJ 4014. It is to be noted this car is registered to JOHN P. CIAMBRONE. Source stated this car is at MLS practically on a daily basis. The pink's Mercury, RJ 7283, driven by EDVARD KOERNER was also in the vicinity of MLS.

On April 10, 1963, at 12 noon the red Valiant, AJ 4014 was the only car in the area.

At 2:30 p.m., April 10, 1963, a Ford Calaxie appeared, BK 4353. This car is registered to ANTOINETTE GUIFFRE, 9143 May Street, Detroit, for a 1961 Ford Convertible.

At 1:00 p.m, April 11, 1963, a black Ford Falcon was parked directly in front of the MLS Office. A white male, 30 years old, Italian, was sitting in the car and appeared to be walting for someone at MLS. This car is registered to DONALD L. BALGW, 14959 Kilbourne, for a 1960 Ford Falcon. The red Valiant, AJ 4014, was on the parking space of MLS.

At 12 noon, April 12, 1963, there was parked on the street a 1962 white over pink Cadillac with license FC 8093. Source stated this is the description of the car usually driven by JACK W. TOCCO but it had a different license. The car usually driven by JACK W. TOCCO has license AJ 6059.

A registration for FG 8993 has not been located. At this time, the red Valiant, AJ 4014 was on the parking space of MLS.

Om Saturday, April 13, 1963, at approximately noon, the Ford Calaxie BK 4353, was at the office of MLS. It is to be noted this car is registered to ANTOINETTE GUIFFRE, previously identified.

On April 15, 1963, at 12:15 p.m., therewas parked in the garage of MLS a 1963 black Pontiac, ED 6977. This car is registered to ANTHONY TOCCO.

On April 19, 1963, source furnished the following information:

On April 15, 1963, at 5:40 p.m., a gray 1962 Continental convertible, AM 4533, driven by DOMINIC CORRADO appeared at MLS. It is to be noted this car is registered to PETRINA CORRADO, 701 Middlesex, Grosse Pointe Park, Michigan, the mother of DOMINIC and TONY CORRADO. Source checked this place again at 6:00 p.m. and this car was still at the MLS office. It was still there at 7:00 p.m. At 8:10 p.m., source observed the car still at the office and noted the lights went on in the office. A few minutes later, DOMINIC CORRADO came from the MLS Office with an unknown woman. She was a Short girl and appeared to be Italian. Both got into AM 4533 and left the area.

On April 29, 1963, source furnished the following information:

At 11:00 a.m., April 29, 1963, the 1962 White over pink Cadillac, FJ 8993 again appeared at the MLS Office. Parked at the rear of this car was a 1961 gray Cadillac, EL 6192. This car is registered to JOSEPH J. SPERRAZZA, 782 Lakepointe, Grosse Pointe Park, Michigan. He is a brother-in-law of JACK and TONY TOCCO. This car left at 11:20 p.m. The driver was a white male, age 30, 5'10", slender build. This answers the description of SPERRAZZA.

Ca Saturday, April 27, 1963, at 11:00 a.m., a red Cadillac convertible appeared at MLS office, FE 7725. This car is registered to CALO B. LICATA, 790 Middlesex, Grosse Pointe Park, for a 1963 Cadillac convertible.
