Re Detroit letter to Kansas City dated March 7, 1963.

Enclosed are nine copies of an FD 302 setting forth information received from the New York Telephone Company. This information was received from Mr. EDWARD L. BRAUNE, Security Supervisor, New York Telephone Company, 4 Albany Street, New York 6, New York.

In view of the fact that telephone LO 3-8483 is a public instrument available for general use, no further investigation is contemplated concerning this matter.

JOSEPH KONOWE is a former symbol informant of the New York Division. The case was recently closed since KONOWE suffered a severe heart attack. KONOWE is an official of the International Brotherhood of Teamsters.

On April 23, 1963, JOSEPH KONOWE (protect identity) was contacted by SA WILLIAM A. VERICKER. He stated that SYLVIA PARIS is a very close friend of the wife of JAMES HOFFA.

Approximately six months ago, PARIS purchased some clothes at Bergdorf-Goodman in New York City, through a contact of KONOWE. Following receipt of the bill, PARIS forwarded payment to Bergdorf-Goodman. However, the latter apparently never received the payment because PARIS received a second bill. It was at this time that she telephonically contacted KONOWE, at his residence, relative to the situation. KONOWE advised that he determined that Bergdorf-Goodman never received PARIS' check. Thereafter, PARIS sent a second check and cancelled payment on the first check.
