2. Will check toll calls for Subject's Michigan Bell Telephone Credit Card #9215648F83 for the past three months. *Als Wilson 4-8*

3. Will determine the registered owner of a late model Cadillac, bearing 1962 Michigan license FG 8993. *Als 4/8*

4. Will follow and report Subject's activities.

Information regarding Michigan telephone numbers was furnished by CSDE 295.

Information concerning toll calls from telephone number 299-2584 in Covington, Kentucky, was furnished by Mrs. MARY O'CONNOR, Cincinnati and Suburban Bell Telephone Company.

Inspector EARL MILLER, Criminal Information Bureau, Detroit Police Department, Detroit, Michigan, advised on March 22, 1963, that they are attempting to make arrangements to interview the Subject in connection with the RAY CALABRESSE murder. He said that the Detroit FBI Office would be advised of the results of this interview.

On February 26, 1963, Mr. EDWARD HARP, Garage Manager, Alden Park Manor, advised that he had not seen SYLVIA PARIS or her car in the past several days. He indicated that the Subject continues to come to Alden Park Manor at least twice a week.

Spot checks at Alden Park Manor on February 26, 27 and 28, 1963, were conducted with negative results concerning the Subject and his car.

On March 6, 1963, Mr. NORMAN RUSSELL, Manager, Alden Park Manor, advised he has heard nothing regarding the Subject or SYLVIA PARIS since he was last contacted. He stated that Apartment 605C (where WILLIS HALL had resided) has been rented and the new tenants would probably move in or April 1, 1963.

On March 7, 1963, Mr. TOM MC QUEEN, Manager, Royal Pontiac, Inc., 400 North Main Street, Royal Oak, Michigan, stated that SYLVIA PARIS had purchased a 1963 Pontiac Grand Prix, Michigan license HL 6065, on January 8, 1963. He stated that she paid \$4,114.00 in cash for this car. He said the only other information they have regarding PARIS was that she indicated that she was associated with the Wayne Window Cleaning Company, Room 310, Veterans Memorial Building, Detroit.

The following information is being set forth regarding subscribers to toll calls which emanated from PARIS' apartment:

On March 5, 1963, Corporal T. FRASER, Royal Canadian Mounted Police, Windsor, Ontario, advised SA ROBERT W. CARTER that La Salle, Ontario, telephone number 734-7815 is in the name of the Essex Golf and Country Club located near La Salle. FRASER advised that this was a very exclusive club which is open to members only.

It was ascertained that New Baltimore, Michigan, telephone number RA 5-0876 is a non-published service which was in the name of ARTHUR CAPLAN, 48859 Salt River Road.
