On 1/19/63, BU 280-C* reported that STEVE MAGADDINO was present at the Magaddino Memorial Chapel from 3:03 PM until 3:16 PM that day.

This information was furnished the Bureau and New York Office by airtel, dated 1/22/63 under the caption "CRIMINAL INTELLIGENCE PROGRAM." It was noted that information received from NY 3461-C-TE indicated that CHARLES LOCICERO, SAM PERITORE, SALVATORE BADALAMENTI, and BENNY D'ALASSANDERO were going to meet with the "Commission" sometime between 1/16/63 and the end of the week in New York City. The purpose of this meeting was to discuss a situation in the "JOE MAGLIOCCO Family" to the "Commission" and how much of this "family" they control. They would also discuss their discontent with MAGLIOCCO as boss. NY 3461-C-TE also indicated that STEVE MAGADDINO was "chairman" of the "Commission", however he did not indicate whether or not he was referring to MAGADDINO as chairman of all members of the "Commission" or just the "Magaddino family."

On 1/19/63, BU 280-C* advised that PETER A. MAGADDINO instructed his cousin, PETER J. MAGADDINO, to accompany ANTONIO MAGADDINO to Room 308, Equitable Life Insurance Company, in the Manufacturers and Traders Trust Company Building in Niagara Falls, New York, regarding their mortgage insurance. He instructed PETER J. MAGADDINO that he was supposed to be there at 11:30 AM that day. Informant stated that he learned from ANTONIO MAGADDINO that JOE BONGI (JOSEPH BONGIORNO, aka Joseph Bongiovanni) is ANTONIO MAGADDINO's nephew.

Shortly after noon that day, informant reported that "BROOKLYN JOE" MALAKOWSKY appeared at the Magaddino Memorial Chapel.

As previously reported, STEVE MAGADDINO was present at the Magaddino Memorial Chapel between 3:03 PM and 3:16 PM that day with PETER A. MAGADDINO.

BU280-C* advised that CONNIE CICCARELLA(PH), who works for the telephone company as an operator, contacted the Magaddino Memorial Chapel and apparently talked with PETER A. MAGADDINO. Informant stated that PETER A. MAGADDINO was interested in identifying CONNIE

The above information concerning MAGADDINO's overeating and the after effects are set out in view of the fact that New York informant 3461-C-TE indicated there was to be a meeting between January 16 and the end of the week by members of the "Commission."

On 1/22/63, BU 280-C* advised that he oeserved "BROOKLYN JOE" MALAKOWSKY and STEVE MAGADDINO at the Magaddino Memorial Chapel between 11:05 and 11:16 AM that day. He stated that PETER A. MAGADDINO and ANTONIO MAGADDINO were also present during the day at the funeral home.

On 1/23/63, BU 280-C* advised that STEVE MAGADDINO was present at the Magaddino Memorial Chapel that morning and made reference to an explosion in his oil furnace which has caused him to decide to convert his heating system at his home into gas furnace. Informant stated that around 11:51 AM that morning a man, he thought possibly was a police officer named JOHNNY LAMARCA, from the Niagara Falls PD, appeared at the Magaddino Memorial Chapel and discussed the health of his family with STEVE MAGADDINO. Informant stated that a great portion of the conversation between JOHNNY LAMARCA and MAGADDINO was in a Sicilian dialect. He stated, however, that JOHNNY LAMARCA (PH) made reference to someone known as "VINNIE", who "crossed a wire some place. Everything was all set. I was going to meet him. At Buffalo he screwed me up. He used to have a little tavern on Cayuga Drive." Informant stated that apparently JOHNNY LAMARCA has been asked to retire by "PETE" who is going to be installed as president of the Pine Avenue Businessmen's Association. LAMARCA made it a point to explain to MAGADDINO that "PETE" (LNU) was against him (LAMARCA).

The informant stated that the conversation between LAMARCA and MAGADDINO continued and reference was made to someone going to see STEVE MAGADDINO and begging that he, meaning the unidentified man, be made Chief of Police in Niagara Falls, New York.

On 1/24/63, BU 280-C* advised that PETER A. MAGADDINO discussed with members of the "Magaddino family" that he felt that the thing (gourme club dinner) should be postponed that night because of the weather conditions
