JOSEPH BROCATO was reportedly living at 435 Hoyt Street, Buffalo, N.Y., in 1957 and was a brother of SAM BROCATO.

CARL ANGELO RIZZO was the subject of the case captioned "CHARLES BONCOR, aka ET AL, ITLT - CONSPIRACY," and was arrested by Bureau Agents at Canton, Ohio on 9/13/50.

SAMUEL C. BROCATO was questioned in connection with the case captioned "UNSUB, Theft of 1500 Mixed Rings Valued at \$75,000.00 from PHILIP KALVER, Youngstown, Ohio, 2/2/50, ITSP." In connection with the ITSP case BROCATO was interviewed in 1950 and stated that he had been in Canton, Ohio on 1/31/50, and stayed with a cigarette machine operator whose name he could not recall. He remained there until 2/2/50. Upon subsequent reinterview on 2/7/50, he stated that he had been in the company of CARL RIZZO on the aforementioned trip and that thay had driven to Canton for the purpose of starting a horse room in that city. He stated that RIZZO was the instigator of the plan inasmuch as he knew a man named PAT (LNU) who was a cigarette machine operator in Canton.

BROCATO was reinterviewed on 3/2/57 in connection with his application for pardon in view of information received that he had been in the loan shark business and he denied this allegation. At this time he was also asked further information concerning the full name and address of PAT whom he had visited in Canton. He advised he could not recall the individual's true name. It is probable that PAT (LNU) is PAT FERRUCCIO referred to by BU 82-C* on 9/12/63.

BU 82-C* and BU 57-C have advised on various occasions that CARL RIZZO is employed by the Board of Elections in the City of Buffalo. The 1963 City Directory lists CARL J. RIZZO, 629 Busti Avenue, Buffalo, as being employed as a maintenance man by the Board of Elections and residing with his wife, MARY F. at the above address. His current telephone number is listed as TT 5-6035.
