Set forth below is information furnished by BU 82-C* on the dates indicated:

November 22, 1963

JAMES V. LA DUCA advised the informant that the prices set by the Consolidated and Famous Linen Supply Companies are so low that the Camellia Linen Supply Co. cannot possibly compete with them in attempting to obtain certain new customers. Subsequently, according to the informant, CHARLES A. MONTANA asked VINCENT SCRO for \$50 to put in "envelope for (FNU) COOK."

LA DUCA later brought up the question with SCRO of negotiating with the "association" and stated that he had talked with MIKE (LNU). The subsequent discussion in this regard was not audible to the informant.

It is possible to conjecture that the "association" referred to by LA DUCA is that association in Buffalo to which all linen supply companies belong, with the acception of the Camellia

Subsequent to hearing the announcement of the death of President KENNEDY on radio, SCRO remarked to the informant, "that just goes to prove, Gumba, you can't step on anybody:"

November 23, 24, 25, 26, 1963

No pertinent information.

November 27, 1963

CI advised that CHARLES MONTANA and SCRO had discussed a company check during which MONTANA asked if there was enough money to cover it. SCRO replied that this was just a paper transaction to his wife, which was being done at the insistence of an unidentified man at the bank. This bank employee has to show where the money is going and has to subordinate these (checks). SCRO indicated that he was disgusted with the business involving subordinating.

Subsequently, CI advised that SCRO, STEVE MAGADDINO and LA DUCA had a conversation in Italian, which is not comprehended by the informant, but which apparently referred to income tax returns for the years 1958, 1959 and 1960.

The substance of this conversation, if pertinent will be made the subject of a separate memorandum when available.

November 28, 1963

No pertinent information.

November 29, 1963

CI advised that SCRO, JAMES LA DUCA, MIKE ERVOLINO and FRANK ERVOLINO had an extensive discussion relating to union matters of Local 168 of the Cleaners and Launderers Union, which will be the subject of a separate memorandum.

During the source of the above conversation, SCRO indicated that JAKIE ROGERS had returned from California, and was then staying at the Camellia Linen Supply Co. where he acts in the capacity of a watchman. During the conversation, ROGERS indicated that he has additional employment and that his foreman's name is CHARLIE CICERO, who lives on Jersey Street, in Buffalo.
