ReBulet to Miami, 1/16/64, captioned, <u>LUCAYAN-BEACH</u> HOTEL, <u>GRAND BAHAMA ISLAND</u>; AR."

PA 623-C* advised that during the evening of 1/27/64, ANGELO BRUNO had a discussion with "PAPPY" (CARLY IPPOLITO) concerning an investment being considered by him in "Bimini." (Prior to discussion BRUNO telephonically contacted one MIKE LNU and told him that he and JOHHNY LNU should immediately join him.)

BRUNO stated to IPPOLITO, "that guy and his son down in Bimini want 50 per cent." He also indicated that the party in Bimini wants BRUNO to buy a "hotel down there," but"his son has a mortgage on the hotel and that makes it tough." BRUNO stated that all he wants is a "casino down there, but the guy wants to get his son off the hook on the mortgage."

IPPOLITO inquired if BRUNO could own a hotel "down there" in view of the fact that he, BRUNO, is a U. S. Citizen. BRUNO replied that he would have to get someone else to appear as the owner, but he would own the controlling shares of "the whole thing."

'BRUNO stated that the "deal in the Bahamas" is a good because it is only one and one half hours from Florida.
