On 11/18/63, BU 280-C\* advised that he had observed STEVE MAGADDINO, JOHN CAMMILLERI, PETER A. MAGADDINO, and at least one other man in conversation.

The following is a verbatim transcript of a portion of the conversation which occurred at this time:

JOHN CAMMILLERI : "I brought him \$1500 this morning. There was the other guy with him too."

STEVE MAGADDINO

"There was a guy this morning, a Government man. I saw him."

PETER A. MAGADDINO:

"Oh, that same guy. He's from Internal Revenue. He's not FBI. Where the hell does he come off to ask who you are associated with?"

"You know his name. A big shot. A big name. He used to bring them girls and everything. We all should do the same thing. Because all these things are lies. They are putting on a circus. They are taking information without any basis for it. That no good bum (this is an apparent reference to JOSEPH VALACHI) has named things and names of 35 years ago. How can they accept this? That cuckold, VALACHI!"

CAMMILLERI subsequently departed remarking that he would return in a few days and commenting that he does not want to use the telephone.

Later on the same date, JOSEPH BONGIORNO was observed with PETER A. MAGADDINO and the subject. BONGIORNO indicated that he was having trouble with his Social Security. The informant ascertained during this conversation that BONGIORNO was born 9/6/16, that his parents were GUSEPPI BONGIORNO and CONSTANCE CAROTTO (ph), and that he has Social Security Number 101-03-8193.

It should be noted that in this discussion the subject stated the correct spelling of BONGIORNO's mother's maiden name was CAROTTO (ph) with two Ts.

Copies of this letter are being furnished to the Bureau, Albany, and New York for information purposes and in view of the conjectural relationship of the Assemblyman, JOSEPH CARLINO.

It is emphasized that this identification is conjectural.
