On 6/10/63, BU 280-C* furnished the following information:

PETER J. MAGADDINO, VINCENT SCRO and JOE BONGIORNO, were observed having a discussion concerning card playing. BONGIORNO stated that as long as they played there would be rumors they were playing for thousands of dollars. He stated the rumor had gone around that they had a big casino and that the next day they had received a call from the police. He then made a reference to \$400 to which SCRO replied that ROY (LNU) had told him about the excellent hand that BONGIORNO had in the game. They then had a general discussion about poker and BONGIORNO's employment at the Paradise (Motel). SCRO then made arrangements to engage in a card game.

BONGIORNO then asked if they had attended a party at the Essex House on 6/9/63, but no further information was developed regarding this.

Later that afternoon, informant overheard PETER A. MAGADDINO telephonically contacting SCRO. He told SCRO that BEN MARINO (BOB MARINO?) had called him, but that he did not know whether he would meet MARINO yet or not.

On the evening of 6/10/63, PETER A. MAGADDINO and SCRO were heard conversing during which PETER A. MAGADDINO mentioned the impossibility of taking a taxi
