Set forth below is information furnished by BU 280-C\* concerning events which occurred at Niagara Falls, N.Y., on the dates indicated:

On 6/5/63, informant advised that SAM (LNU) visited PETER A. MAGADDINO. From information furnished by this informant on 6/5 and later on 6/15, it is possible to identify SAM as being SALVATORE MIANO, aka Sam.

SAM told PETER A. MAGADDINO that he had made what he considered a fair offer to an unidentified person involving squaring off a building, but had not heard anything from this man. He had contacted AL (Attorney AL PACINI?) that morning and had been told that this other man's attorney had not called.

MIANO pointed out that he actually wanted no part of this matter, but only wanted to be a silent partner
