SUBJECT: STEVE MAGADDINO

On 10/8/63 BU 297-C-TE advised that he was in attendance at a stag party honoring CHARLES A. MONTANA's future son-in-law, LEONARD TERRITO, which was held at Augustine's Cafe, 295 Washington Street, on 10/6/63 at 7:00 p.m.

Informant stated he arrived at approximately 7:30 p.m. and noted that the tables were arranged in such a way that they converged or were distributed around one table of prominence at which STEVE MAGADDINO and his party were seated.

The occupants of the tables closest to STEVE MAGADDINO were made up of those closest to STEVE MAGADDINO and each table was presided over by one of STEVE's close associates or members of his blood family.

Informant stated that there were six people seated at STEVE MAGADDINO's the tables in the main diningroom and at table were seated the following individuals:

Informant stated that everyone was well behaved, that the food was excellent and that the drinks were plentiful. Informant continued that when he entered he was met by JAMES IA DUCA and introduced to the people at LA DUCA's table who were elderly men of Italian extraction whose identities were unknown to the

informant. Informant paid his respects to STEVE and was introduced to the men at STEVE's table but could not recall their names. The informant then proceeded to VINCENT SCRO's and CHARLES MONTANA's tables and subsequently to his own. Informant stated that there were no speeches and the purpose of the stag was to raise money for the prospective son-in-law. CHARLES MONTANA advised the informant that 500 tickets had been sold at \$5 each and approximately 260 people were in attendance at the party.

At approximately 10:15 p.m. the informant decided to leave and approached VINCENT SCRO's table in order to express his regrets at having to leave his party. At this time VINCENT SCRO determined from the informant that it was 10:15 p.m. and VINCENT glanced toward STEVE. STEVE stood up at which time all thoseinattendance ceased their activities and preparation began for STEVE MAGADDINO's departure. According to the informant two groups of men left the cafe one group going north and the other south and each group examined the block prior to MAGADDINO's Shortly thereafter two more groups ien left and took positions on both sides of the door and on the curing which separated the street traffic from the door of the cafe. this point PAT NATARELLI and JAMES LA DUCA left the cafe walked west and took positions near the parking lot. SAM RANGATORE, the chauffeau for STEVE and another young Italian man had left the cafe and walked toward the parking loc. RANGATORE ordered the younger man to start the car and bring it to the edge of the parking lot. It is the informant's opinion that this was done in that if the automobile had a bomb in it the younger man was more expendable than RANGATORE or MAGADDINO. Subsequently MAGADDINO came out of the door supported by FRED RANDACCIO who was holding his left arm and VINCENT SCRO who was on his right. According to the informant it is apparent that SCRO and RANDACCIO are in solid with the old man. Just before MAGADDINO entered his Cadillac, he called the informant over and told him good bye and said he would see him this week.

Informant will attempt to secure names of individuals sitting at the head tables.

As previously reported, informant purchased three tickets to this affair. Informant made available one of the tickets which his being retained in the 1A Section of 92-337 La Cosa Nostra.
