On 10/21/63, BU 297-C-TE advised that he was in attendance at the reception following the marriage of the daughter of CHARLES A. MONTANA on 10/19/63, at Como's Restaurant at Niagara Falls, New York.

Informant stated that as he entered he was met by PETE MAGADDINO (STEVE MAGADDINO's son), VINCENT SCRO, and SAM RANGATORE who were the unofficial greeters and who directed the people to the ballroom area. From the entrance, informant stated that he went by the bar area and said a few words to PAT NATARELLI and FRED RANDACCIO and then continued to the reception line at which time he met STEVE MAGADDINO's wife. Informant mentioned that he mingled in the group for some time meeting various people till approximately 8:20 p.m. when MAGADDINO made his entrance.

According to the informant, everyone paid homage to STEVE MAGADDINO and when STEVE MAGADDINO saw the informant, he called for him and hugged him with both hands. MAGADDINO advised the informant that there was plenty of food, dancing, and drinking and if there was anything he wanted this night, it would be gotten for him. MAGADDINO called JAMES V. LA DUCA and requested LA DUCA to see to the welfare of the informant and his guest. Informant stated that he observed the following people in attendance at the reception in addition to those previously identified:

An individual who had a hole in his head, with ugly scar tissues who was described to the informant as being worked over with a hammer.

During the evening JAMES LA DUCA mentioned to the informant that Buffalo is opening up and that LA DUCA is contemplating opening up or operating a high class of prostitutes and asked the informant if he would be interested in running this operation. LA DUCA explained that Buffalo needs high class prostitutes and that the operation would work as follows:

Informant would obtain photographs of the prostitutes from this album and successful men such as lawyers, judges, priests, etc. would select the girl of his choice and the informant would deliver the girl to the man and subsequently pick her up at a pre-arranged time. Informant would get a percentage of the action. LA DUCA stated that this would be a real high class operation, that Buffalo is in need of this type of service, and that if the informant is highly regarded if the plan works out, he will be given a piece of the percentage of the action.
