No further investigation is being conducted concerning the subject's involvement in the operation and control of Local 3108, Bowling Alley Employees Union. Interviews conducted and reported in the referenced report as well as those appearing herein have, to a great degree, substantiated the information as originally furnished by NY 3123-C\*. It is apparent that the original ideas of the subject, BARBIERI, and LA PONZENA was to organize all alleys in Metropolitan, NY, Nassau and Suffolk Counties, which would have provided, through various schemes, substantial illegal revenue.
