It should be noted that NYO has not obtained full and sufficient information concerning the pension loan to the Howard Park Hospital. It is anticipated, however, that full facts concerning source's involvement in this loan will be forthcoming within one week at which time a detailed letterhead memorandum will be prepared on this matter. It is suggested that no investigation be sinstituted on this loan at this time.

Concerning the Forum Motor Lodge, source has advised that this loan has not reached the stage of completion. However, leads set out in referenced Buairtel dated 5/2/62 Ob concerning this loan will be handled, including the possibility of informant's withdrawal from this matter. Bureau will be 🔪 advised by appropriate communication of the results of further discussion in this case.

This office at present has very little information concerning the Fairlawn Memorial Hospital other than that set out in referenced Buairtel dated 5/3/63, with the possible exception of the involvement of JAMES PLUMERI in this loan. This matter will be discussed in detail with the informant Sin the near future,

Concerning the Forum Motor Lodge and Howard Park Hospital loans some information set out in Nyairtels dated 4/19/63 and 4/23/63 is being omitted from the enclosed d letterheads in order to protect the source in these matters.

At the request of AUSA BAER, a new case captioned, "GEORGE BARASCH, SECRETARY-TREASURER, LOCAL 815, IBT AND PRESIDENT, ALLIED TRADES COUNCIL; LMRA-1947," NY 122-1142, has been opened. The Bureau is being advised by separate communication of the results of the examination of the IRS and BLMR material and subsequent doscussion with AUSA BAER following this examination.
