Information has been developed that JOSEPH ANTHONY STRACI, New York top hoodlum, is a close associate of KORNREICH and negotiated a \$300,000 loan through HENRY CHARTIER, President of Local 32E, for IZZY SCHWARZ, a former New York labor racketeer.

Information furnished by NEWHOUSE alleging SILVIO MARINO was involved in "kickback" schemes in connection with dental care plans for unions is currently being considered by the New York Office as a possible violation of the Labor Management Relations and Disclosure Act under the caption, "SILVIO MARINO, LMRDA-IM".
