was blinded when acid was thrown in his face, presumably by the deceased, ABRAHAM TELVI. The subject, CARLINO, along with others, was held as a material witness in this matter. Also involved in this case was JOHN DIOGUARDI. This matter was never brought to trial due to a change in the testimony of the major witnesses in this case.

It is to be noted that several individuals, whose reliability is not known, have stated in the past, that the subject, CARLINO, is a "button man", however, none have advised to what "family" subject belongs. Because of subject's close association with some of the members of the THOMAS LUCHESE "family", the subject is for the present, being carried with that group.
