NY 4860-PC was interviewed on 2/24/65, 3/18/65,
3/31/65 and 4/23/65.

To date, informant has not furnished any information of value regarding the organized underworld's activities. He willingly meets with SAS FRANK R. GERRITY and JEROME N. BOWERS and appears cooperative about discussing burglars, check passers, pimps and prostitutes, but has not furnished any information of value concerning the above.

On 3/30/65, shortly after the EMILE GRIFFITH vs. JOSE STABLE fight for the Welterweight Title, informant, during conversation, said that STABLE was controlled by TONY "Pro" ~~PROVENZANO~~.

On 4/23/65, informant was specifically asked about JOSEPH FARACCO aka - FUGITIVE; CRV, NY File 76-2663. Informant said he knew subject as GEORGIE FARACCO and stated that we should save our time and forget about looking for "Georgie". Informant said that "Georgie" was "dumped" about two years ago. Informant added that he is personally acquainted with "Georgie's" wife and she believes her husband to be dead.

It is believed by the NYO that since informant willingly meets with Special Agents and will discuss some criminal matters, further efforts should be made to develop this informant as an active top echelon criminal informant.
