On November 20, 1964, NK T-2 advised that he had been fired by his employer in November, 1964, for allegedly drinking on the job. NK T-2 denied the charge and the matter is now in arbitration.

NK T-2 stated that he went to PROVENZANO in an attempt to get his job back and PROVENZANO, in no uncertain terms, told him he would not help him. Shortly thereafter on November 19, 1964, the informant received an anonymous telephone call offering to help him keep his case out of arbitration and get him his job back for \$50.00. The unknown individual attempted to set up a meet to which the informant was to come alone. NK T-2 felt that this was an attempt to get him alone and work him over because of his dispute with PROVENZANO.

Informant stated that PROVENZANO has lost considerable weight and complains that he is suffering from sclerosis of the liver. According to the informant, the rank and file feeling in Local 560 is that if PROVENZANO's appeal is denied by the United States Supreme Court and he thereafter goes to jail he will be succeeded by SALVATORE BRIGUGLIO, a Business Agent for Local 560, rather than by his brother, SALVATORE PROVENZANO, aka. Sammy, who has, until this time, been considered his logical successor.

On December 14, 1964, NK T-2 advised that PROVENZANO recently held a meeting of his shop stewards and proposed that the terms of the elected officers of the local be increased from two to three years. Informant stated that no official notice of this has been given to the rank and file of the local and as a matter of fact PROVENZANO has apparently suspended the regular membership meetings and they will, hereafter, be held only when he desires to have them.

On December 8, 1964, NK T-3 advised that he continues to meet with PROVENZANO on certain union affairs at regular intervals. PROVENZANO is obviously concerned about his case which is before the Supreme Court and does not appear to be a well man physically. It is the informant's opinion that PROVENZANO will do nothing in his union or personal activities which might endanger this appeal.

In the opposition faction in Local 560, it is noted they are becoming more powerful and more vocal and there is apparently the general feeling that they could beat PROVENZANO in an honest election if their civil suit challenging the
