NOTE:

Subject is organization of Taiwan Independence Movement (TIM) dedicated to overthrow of present Chinat Government and whose members attempted assassination Vice Premier, Chinat Government. PENG Ming-min, leader of TIM who escaped from Taiwan, surfaced in Sweden, is presently in U.S. His attorney and also attorney of subject is Luis Kutner who has contacted both Chicago Office, local police and State Department to seek protection for PENG from Chinats. By letter dated 10-2-70 the Director informed Secretary of State Rogers that Chinat Government deeply distressed over State plans to issue visa to PENG and the fact that his entry into U.S. would have obvious internal security ramifications. This information was also furnished to Dr. Kissinger at White House, the Attorney General and the Commissioner of INS. On 11-3-70 [Chinat Ambassador CHOW Shu-kai] (S) furnished information to SA Robert L. Pence regarding Kutner's approach to [Chinats]. ~~(S)~~
