LA 9883-C-TE ADVISED ON AUGUST 17, 1976, THAT FRANK THOMAS, WHOM HE HAS KNOWN FOR MANY YEARS, DIED APPROXIMATELY TWO AND ONE-HALF MONTHS AGO FROM A HEART ATTACK.

EMMETT MURPHY, WEST COAST DIRECTOR, THOROUGHBRED RACING PROTECTIVE BOARD (TRPB), ADVISED ON AUGUST 18, 1976, HE WAS PERSONALLY ACQUAINTED WITH FRANK THOMAS PRIOR TO HIS DEATH AS HE WAS IN DAILY ATTENDANCE AT SANTA ANITA RACETRACK, ARCADIA, CALIFORNIA. THE LAST RACING MEET FOR SANTA ANITA OPENED ON DECEMBER 26, 1975.
