FOR \$183,000 OF ANTIQUE CARS ON JULY 23, 1976, AND ON JULY 27, 1976, CARRAFFA AND JAY KNOHL SAW CARRAFFA'S ATTORNEY TO DETERMINE THE PENALTIES FOR FILING A FALSE THEFT REPORT. CARRAFFA DISAPPEARED ON JULY 28, 1976, AND WAS SUBSEQUENTLY FOUND DEAD IN THE HUDSON RIVER, NEW YORK CITY, UNDER REPORTEDLY SIMILAR CONDITIONS AS ROSELLI. CARRAFFA MAY HAVE BEEN IN FLORIDA AT THE TIME OF ROSELLI'S DISAPPEARANCE ON JULY 28, 1976. PICCERELLI WAS INTERVIEWED BY MONTGOMERY COUNTY MARYLAND POLICE DETECTIVE ON AUGUST 6, 1976, AT THE RESIDENCE OF DAVID PAUL KNOHL, OLNEY, MARYLAND. PICCERELLI FURNISHED HIS ADDRESS AS 32402 BARCLAY SQUARE, WARREN, MICHIGAN, AND SAID HE WAS RETURNING TO DETROIT TO OPEN A RESTAURANT NAMED "THE THREE OF US." PICCERELLI'S FORMER WIFE, JANICE, WHO DATED SEVERAL LCN FIGURES IN CHICAGO, WAS FOUND DEAD ON JULY 21, 1976 OF AN APPARENT OVERDOSE. JANICE PICCERELLI HAD WORKED AT THE MILLIONAIRES CLUB IN CHICAGO.
