Reference Bureau teletype to all SACs dated 8/13/76 and Milwaukee teletype to Director dated 8/14/76.

As reported in referenced Milwaukee teletype, no pertinent information concerning ROSELLI contained in files of Milwaukee Division.

On 8/20/76, MI 607-C-TE advised he did not have any information in regard to captioned subject. Source stated he heard approximately one year ago that ROSELLI was in "trouble" with the Chicago mob but had no specific details of the nature of the trouble. Source said he is not in the position to obtain information about the murder of ROSELLI.

On 8/24/76, MI 7005-PC advised he has no positive information concerning the murder of ROSELLI. Source stated, however, that several months ago he heard that ROSELLI was in trouble for testifying before a Federal Grand Jury. Source further advised that the indications he received pointed to hoodlums from the West Coast, possibly the San Diego area.
