FORMER MM 4205-PCI WAS CONTACTED INITIALLY CONCERNING THE CAPTIONED MATTER ON AUGUST 19, 1976, AT WHICH TIME HE DID NOT SPECIFICALLY KNOW ROSELLI, BUT DID FURNISH GOOD INFORMATION HELPFUL TO MIAMI AND FBI NOT AVAILABLE FROM OTHER SOURCES.

ON SEPTEMBER 1, 1976, HE VOLUNTEERED TWO ADDITIONAL NAMES OF

PERSONS WHO ARE EXTREMELY KNOWLEDGEABLE OF CIA CUBAN ACTIVITIES

DURING THE PERTINENT PERIOD. THEY ARE JORGE NOBREGAS, BORN

JULY 22, 1924, IN CUBA AND RAFAEL GARCIA VANGO, DESCRIBED AS

SANTO TRAFFICANTE'S LAWYER IN CUBA. BOTH VANGO AND NOBREGAS

SOURCE IDENTIFIED GAETON FONZI AS SEN. SCHWEIKER'S MIAMI INVESTIGATOR, AND STATED THAT HE IS CONSIDERED UNRELIABLE IN THAT A RECENT REPORT HE SUBMITTED TO A SENATE INVESTIGATING COMMITTEE WAS NOT ACCEPTABLE.

SOURCE SUGGESTED ON AUGUST 19, 1976, ANTONIO DE VARONA AND HIS BROTHER-IN-LAW, KNOWN AS FORMER CAPTAIN AGOSTO, WHOSE PROPER NAME IS (FNU) RUIZ SANCHEZ, AS ADDITIONAL PERSONS WHO ARE KNOWLEDGEABLE OF CIA ACTIONS DURING THE PERTINENT PERIOD.

*File* *sub* ~~COMMANDER~~ BARQUIN WAS IDENTIFIED BY THE SOURCE AS ~~COMMANDER ROLANDO~~ BARQUIN, WELL-KNOWN FIGURE IN THE BATTLE TO ESTABLISH FIDEL CASTRO PRIOR TO CASTRO'S TAKEOVER. BARQUIN WAS HEAVILY UTILIZED BY THE CIA, AND IS ALSO KNOWLEDGEABLE OF CIA ACTS DURING THE PERTINENT PERIOD.

PER THE RE BUREAU TELETYPE, MIAMI HAS BEEN FORBIDDEN TO RECONTACT THIS SOURCE, "IN VIEW OF HIS BACKGROUND, AND THE AVERAGE QUALITY OF INFORMATION FURNISHED TO DATE".
