ON SEPTEMBER 15, 1976, PG 603-PC, IN RESPONSE TO A QUESTION REGARDING WHAT SOURCE KNEW ABOUT THE ROSELLI MURDER, SOURCE ADVISED THAT A RECENT EX-CON BY THE NAME OF GALENTI (PHONETIC) HAD SOME PARTICIPATION IN THE HIT ON ROSELLI, AND PROBABLY WAS RESPONSIBLE FOR IT. GALENTI WAS FURTHER IDENTIFIED AS BEING APPROXIMATELY AGE 60, AND ASPIRING TO TAKE OVER CARLO GAMBINO'S POSITION IN NEW YORK. SOURCE ADVISED THAT DUE TO ROSELLI'S AGE, THE MOB KNEW ROSELLI WOULD EVENTUALLY TALK TO THE GOVERNMENT INVESTIGATORS CONCERNING CASTRO ASSASSINATION PLOTS. THE REASON THOUGHT TO BE FOR ROSELLI'S TELLING ALL WAS THAT HE WANTED TO AVOID GOING TO JAIL, WHICH THE MOB FELT WOULD BE AN UNEXPECTABLE ALTERNATIVE TO ROSELLI IF HE WOULD NOT TALK. A FURTHER COMMENT BY THE SOURCE WAS THAT YOUNGER MOB MEMBERS DID NOT FEAR JAIL, BUT OLDER MOB MEMBERS DID BECAUSE THE OLDER MEMBERS ARE AFRAID OF DYING BEFORE THEY GET OUT OF JAIL.
