GERARDO CATENA, LCN CAPO OF GENOVESE FAMILY, INTERVIEWED AT RESIDENCE, 2100 COCONUT ROAD, BOCA RATON, FLORIDA, AND SAID HE KNEW OF JOHN ROSELLI ONLY THROUGH NEWSPAPER ACCOUNTS AND HAD NO INFORMATION RELATING TO HIM.

FORMER MM 4205-PCI CONFIRMED THROUGH ORTA RELATIVES THAT JUAN ORTA IS IN CUBA.

SOURCE ALSO ADVISED THAT ROLANDO CUBELA, IDENTIFIED IN PUBLIC PRESS AS CUBAN CIA AGENT AM/LASH, ALSO IS IN CUBA WHERE HE IS A PRACTICING MEDICAL DOCTOR WHO HAD HAD NO RETALIATION BY FIDEL CASTRO, LEADING SOURCE TO BELIEVE CUBELA WAS POSSIBLE DOUBLE AGENT.

INVESTIGATION CONTINUING RE 55 GALLON DRUMS THROUGH FLORIDA TALLOW CO., HALLANDALE, FLORIDA; AND FLORIDA PROCESSING COMPANY, MIAMI TO DEVELOP IDENTITIES AND LOCATIONS OF HOODLUM CONTROLLED RESTAURANTS WITH OBJECT OF FURTHER IDENTIFYING DRIVER USED IN THIS CASE.

FRANK FIORINI, AKA FRANK STURGIS FORMER SECURITY DIRECTOR OF FIDEL CASTRO'S AIR FORCE AND CONSEQUENTLY CASTRO'S REPRESENTATIVE FOR CASINO SECURITY IN HAVANA STATED HE DID NOT KNOW ROSELLI. DURING AND AFTER THE CUBAN REVOLUTION HE, FIORINI COOPERATED WITH CIA. IN HIS OPINION THE MAFIA KILLED ROSELLI.
