AT 4042-PC HAS PREVIOUSLY ADVISED THAT HE HAS SOURCES IN  
NEW YORK AND MIAMI AREA WHO MIGHT BE ABLE TO FURNISH INFORMATION  
IN CONNECTION WITH CAPTIONED CASE.

PC HAS NOT TRAVELED TO NEW YORK AT THIS TIME AND HIS TRAVEL  
TO MIAMI HAS BEEN POSTPONED AS IT IS IN CONNECTION WITH A TRIAL  
THAT HAS BEEN CONTINUED UNTIL EARLY PART OF NOVEMBER, 1976.

PC ADVISES THAT HIS SOURCE IN MIAMI WOULD LIKELY HAVE SOME  
KNOWLEDGE OF THIS MATTER AND PC WILL BE STAYING AT HIS SOURCE'S  
RESIDENCE WHILE IN MIAMI AND IS, THEREFORE, OPTIMISTIC THAT HE  
WOULD BE ABLE TO OBTAIN SOME INFORMATION RE CAPTIONED MATTER.
