LA 4396-C* advised that ROSSELLI has been residing at Los Angeles apartment during current week. On morning of 7/12/63, he made arrangements to pick up MAURICE H. FRIEDMAN at about 9:30 a.m. FRIEDMAN is close friend of ROSSELLI and part owner of New Frontier Hotel.

LA 4268 advised ROSSELLI was at the Friar's Club in Beverly Hills on afternoons of July 9, 10 and 11, 1963. FRIEDMAN also present on these occasions. On 7/9/63 ROSSELLI had conversation with one TOMMY NOONAN, motion picture producer who operates own company and made arrangements to meet NOONAN the following afternoon presumably at the Friar's Club. On 7/9/63, LA 4268-C also furnished information that ROSSELLI planned to go to dinner that evening with JONIE TAPS, motion picture official, and others.

LA 4268-C advised that on 7/11/63, ROSSELLI was playing cards at the Friar's Club with MAURICE FRIEDMAN, IRVING J. LEFF and others from 4:00 p.m. until at least 5:30 p.m. when informant left the club.
