ROSSELLI returned to his Los Angeles apartment on evening of 3/20/63. According to LA 4396-C\*, on the evening he returned, he talked to an unknown person and made an appointment to see the person about 12 o'clock. FISUR conducted on 3/21/63 revealed ROSSELLI did not leave his apartment until after one P.M. and then went directly to the Friar's Club in Beverly Hills, California.

LA 4396-C\* advised that the morning of 3/21/63 ROSSELLI called to talk to ROBERT MAHEU but MAHEU was not in and ROSSELLI left a message that he could be reached at the Friar's Club. MAHEU is a well known private investigator and former FBI Agent who is a friend of ROSSELLI and a person with whom ROSSELLI has had business dealings in the past.

LA 4268-C advised that ROSSELLI was observed by informant at the Friar's Club shortly after 3:00 P.M. on 3/21/63. ROSSELLI was with IRVING J. LEFF and MAURICE H. FRIEDMAN, part owners of the New Frontier Hotel in Las Vegas, Nevada. They were examining what appeared to be an
